Tree Sale Underway

Stephenson County Soil and Water Conservation District annual tree sale is underway for 2022. Each year the district sells bare root tree, evergreen, and shrub seedlings to increase efforts to provide energy conservation and/or habitat cover for wildlife. These plants are for conservation purposes only and shall not be used as ornamentals or for landscaping. Deadline to order is Thursday, March 10, 2022. (No orders will be accepted after the deadline!).

Only one new species was added to our sale this year - Canaan Fir. Back by popular demand are Persimmon and Black Elderberry.

Evergreens available include Canaan Fir, White Pine, Norway Spruce, and Colorado Blue Spruce. The evergreen stock is only available in smaller sizes this year and we could not get American Arborvitae (White Cedar).

Deciduous Trees include Persimmon, Black Walnut, Quaking Aspen, Shagbark Hickory, White Oak, Bur Oak, Swamp White Oak, and Sugar Maple.

Shrubs available include Black El-

derberry, Red osier Dogwood and High-bush Cranberry.

Additional items for sale include marking flags, Plantskydd Animal Repellent, tree tubes, tree stakes along with bat houses, blue bird houses and wood duck houses.

Tree Order pick-up is scheduled for Thursday, April 14, 2022, 8:00 a.m. to 5:00 p.m. at Stephenson County Fairgrounds, Fairgrounds Road, Freeport IL. A reminder postcard will be sent to confirm the pick-up date, time, and location.
